1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1) The valuer must be registered by the Insolvency and Bankruptcy Board of India for Asset Class of 'Securities or Financial Assets' under the provisions of the Companies (Registered Valuers and Valuation) Rules, 2017, read with up-to-date amendments.
- 2) The valuer is required to possess a registered office in Delhi & NCR.
- 3) Completion Period : The assignment shall be completed on submission of all requisite deliverables within a period of 20 days from issuing Letter of Engagement (LOA).

4) Carry out the assignment for providing the Five (5) valuation report of Corporate Guarantee issued by IR CON (holding company) to Banks on behalf of its Subsidiary Companies with the requirements of all applicable provisions.

5) Estimated Cost of the work:

Bidders has to bid the cost at all-inclusive rate for providing Five (5) valuation report for corporate guarantee valuation of Five Subsidiary companies. Estimated total cost for providing the Five (5) valuation report is Rs.1,60,000/- (One Lakhs Sixty Thousand Only) inclusive of all the taxes and out of pocket expenses.

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace.
